

#### **Interests and Duties of associated companies**

UniSuper Management Pty Ltd (USM) is wholly owned by UniSuper Limited (USL), the trustee of UniSuper (the Fund), and contracts with USL.

The Directors of USL are also directors of USM. (The CEO is a director of USM only.) Directors of USM have duties to act in the best interests of USM and its shareholder. Any potential conflict is mitigated by the shares in USM being held on trust by USL for the benefit of the Fund's members, aligning the interests of USM's activities and undertakings and those of the Fund's members.
